- 2) Patent on registered email called ‘**METHOD FOR CERTIFYING THE SENDING OF ELECTRONIC MAIL**’ or ‘**PROCEDE DE CERTIFICATION DE L’ENVOI D’UN COURRIER ELECTRONIQUE**’ and with number **CA 2862557**. The patent has been granted for a period of 20 years.

These two patents are key for the certification service to be offered by telecommunication operators and postal operators in Canada.

Likewise, the Taiwan Intellectual Property Office (TIPO) has granted Lleida.net patent number 105143540 called ‘**METHOD FOR THE CERTIFICATION OF ELECTRONIC MAIL CONTAINING A RECOGNISED ELECTRONIC SIGNATURE ON THE PART OF A TELECOMMUNICATIONS OPERATOR**’ on its registered email method with a qualified electronic signature, also for a period of 20 years.
