**Additional information to the market at the request of the CNMV**

Under the provisions of Article 17 of Regulation (EU) No 596/2014 regarding market abuse and Article 227 of the consolidated text of the Spanish Stock Market Act, approved by Spanish Royal Legislative Decree 4/2015, of 17 March and related provisions, as well as Circular 3/2020 BME GROWTH of BME MTF Equity on information to be provided by Growing Companies, we hereby inform you of the following information relating to LLEIDANETWORKS SERVEIS TELEMÀTICS, S.A.: (hereinafter “Lleida.net”, or the “Company” or the “Enterprise”) brings to your attention the following information that has been prepared under the exclusive responsibility of the issuer and its administrators:

In light of the Civil Chamber of the Supreme Court’s order, dated March 15, 2022, which dismissed appeal No. 5444/2019 filed by Mr Francisco Sapena, and thereby upheld the ruling of the Court of First Instance No. 2 of Lleida in ordinary proceedings No. 957/2016, confirming the validity of a previously disputed put option that had been subject to litigation; and in the interest of full market transparency, given the significant impact on both current and former shareholders, the Company provides the following additional details related to the ongoing procedure, previously disclosed in the Relevant Information notices published on April 25, 2022, May 6, 2022, and May 16, 2022, which the Company is aware of and has been requested to disclose by the CNMV:

On May 13, 2022, Mr Francisco Sapena notified the subsequent successor, CANTABRO CATALANA DE INVERSIONES S.A., summoning them to appear on May 29 at 1:00 PM at the notary office of Mr. Pablo Gómez Clavería in Lleida to execute the corresponding sale deed for 1,137,893 shares held by them. This appointment was later rescheduled to May 30.

On May 30, 2022, at 2:00 PM, due to the absence of a representative from CANTABRO CATALANA DE INVERSIONES S.A., Notary Public of Lleida, Mr. Pablo Gómez Clavería, documented the occurrence and a copy was made of the nominative bank check presented by Mr. Francisco Sapena.

Subsequently, at 2:30 PM, CANTABRO CATALANA DE INVERSIONES S.A. informed Mr Francisco Sapena via burofax that they would not attend the proposed meeting, reiterating their renouncement of the exercise of the put option, as communicated on October 19, 2020. They further asserted that the obligations to transfer and deliver the shares of Lleida.net by the option holders had been extinguished.
