Under the provisions of Article 17 of the Regulation (EU) No 596/2014 regarding market abuse and article 227 of the modified text of the Spanish Stock Market Act, approved by Spanish Royal Legislative Decree 4/2015, of 23 October and related provisions, as well as Circular 3/2020 of BME MTF Equity on information to be provided by Growing Companies, we are hereby informing you of the following information relating to LLEIDANETWORKS SERVEIS TELEMÀTICS, S.A.: (hereinafter "Lleida.net", or the "Company" or the "Enterprise") brings to your attention the following information that has been prepared under the exclusive responsibility of the issuer and its administrators:

Lleida.net is committed to providing its shareholders with total and utter transparency and complies meticulously at all times with the recommendations of the Spanish Securities Market Commission (CNMV) and the Spanish and European legal frameworks governing the capital market.

Therefore, and given the implications that significant shareholder transactions on Lleida.net shares represent for the sound performance of the Company, and in view of the interests of all the Company's investors, we hereby make the following information available to you:

1. The Company receives daily information regarding the updated shareholding position of the Company from IBERCLEAR. IBERCLEAR is the Spanish Central Securities Depository and one of the companies of Bolsas y Mercados Españoles (BME). It provides, inter alia, shareholder and beneficial owner identification services and timely identification of ultimate shareholders daily. The information it provides to issuers is deemed official.

2. According to the official information provided by IBERCLEAR's platform, there is evidence that between 24 November 2020 and 2 March 2021, two significant shareholders, namely SEPI DESARROLLO EMPRESARIAL S.A. and CÁNTABRO CATALANA DE



INVERSIONES S.A., allegedly sold, simultaneously and in agreement, almost the same number of Lleida.net shares, every day, for 57 market sessions. This sales performance is mirrored in the table below:

- Throughout these allegedly simultaneous and concerted sales, Lleida.net's shares fell from 7.05 euros to 5 euros, that is, by 29.1 per cent.
- On 29 October 2020, the aforementioned shareholders held 14.16% of the shares of Lleida.net, 7.08% each of them. On 24 March 2021, they were no longer shareholders of the Company, at which point Lleida.net's shares fell from 8.90 euros to 5.15 euros or 42.2 per cent.
- SEPI DESARROLLO EMPRESARIAL S.A. and CÁNTABRO CATALANA DE INVERSIONES S.A. are both successor to the BANESTO ENISA SEPI DESARROLLO

FCR fund, which was dissolved in 2019. The BANESTO ENISA SEPI DESARROLLO FCR fund eventually held 3,413,680 shares, accounting for 21.27% of the Company's total capital.

On 1 April 2022, Sisco Sapena, Lleida.net's CEO, by resolution of the Company's Board of Directors, brought this information to the attention of the CNMV to find out whether it could constitute alleged market manipulation, following the applicable legislation on Market Abuse.

The Board of Directors of the Company, convened on 31 May 2022, agreed to bring this information to the attention of the market and the shareholders for their knowledge and understanding.
