## Lleida.net has been granted 72 new European patents for its innovative digital signature solutions.

Under the provisions of Article 17 of the Regulation (EU) No 596/2014 regarding market abuse and article 227 of the modified text of the Spanish Stock Market Act, approved by Spanish Royal Legislative Decree 4/2015 of 23 October and related provisions, as well as Circular 3/2020 of BME MFT Equity on information to be provided by Growing Companies, we are hereby informing you of the following information relating to LLEIDANETWORKS SERVEIS TELEMÀTICS, S.A: (hereinafter "Lleida.net", or the "Company "or the "Enterprise") brings to your attention the following information that has been prepared under the exclusive responsibility of the issuer and its administrators:

The Spanish-listed company Lleida.net (OTC.US) (ALLLN.PA) (LLN.MA), a leading player in the registered electronic signature, notification and contracting industry, has been granted in one go 72 new patents in Europe for its electronic contract and electronic signature certification methods.

The European patent EP3461074 on its EIDAS-certified contracting method called "PLATFORM AND METHOD OF CERTIFICATION OF AN ELECTRONIC CONTRACT FOR ELECTRONIC CERTIFICATION AND TRUST SERVICES (EIDAS)" has been recognized in:

Albania, Germany, Austria, Belgium, Bulgaria, Switzerland, Cyprus, Czech Republic, Denmark, Estonia, Spain, Finland, France, United Kingdom, Greece, Croatia, Hungary, Ireland, Iceland, Italy, Liechtenstein, Lithuania, Luxembourg, Latvia, Monaco, North Macedonia, Malta, Netherlands, Norway, Poland, Portugal, Romania, Serbia, Sweden, Slovenia, Slovakia and Turkey.

Also, patent **EP3767875** for its encrypted certified contracting method called **"METHOD FOR ELECTRONICALLY SIGNING CONTRACTS"** has been recognized in the following countries:

Albania, Belgium, Bulgaria, Switzerland, Cyprus, Czech Republic, Denmark, Estonia, Spain, Finland, France, United Kingdom, Greece, Croatia, Hungary, Ireland, Iceland, Italy, Liechtenstein, Lithuania, Luxembourg, Latvia, Monaco, North Macedonia, Malta, Netherlands, Norway, Poland, Portugal, Romania, Serbia, Sweden, Slovenia, Slovakia and Turkey.

These grants, valid for 20 years, in European countries, bring to 298 the number of global patents that Lleida.net has received for its certification and notification methods, as well as for digital witness in contracts, and electronic notifications

The granting of these 72 new patents will allow the company to generate additional lifetime revenues in the SaaS business line, estimated at 16 million euros.

Lleida.net's growth strategy in the electronic signature, notification and contracting market is based on a solid growth policy in intellectual property, as well as a reinforcement of its internationalization policy
