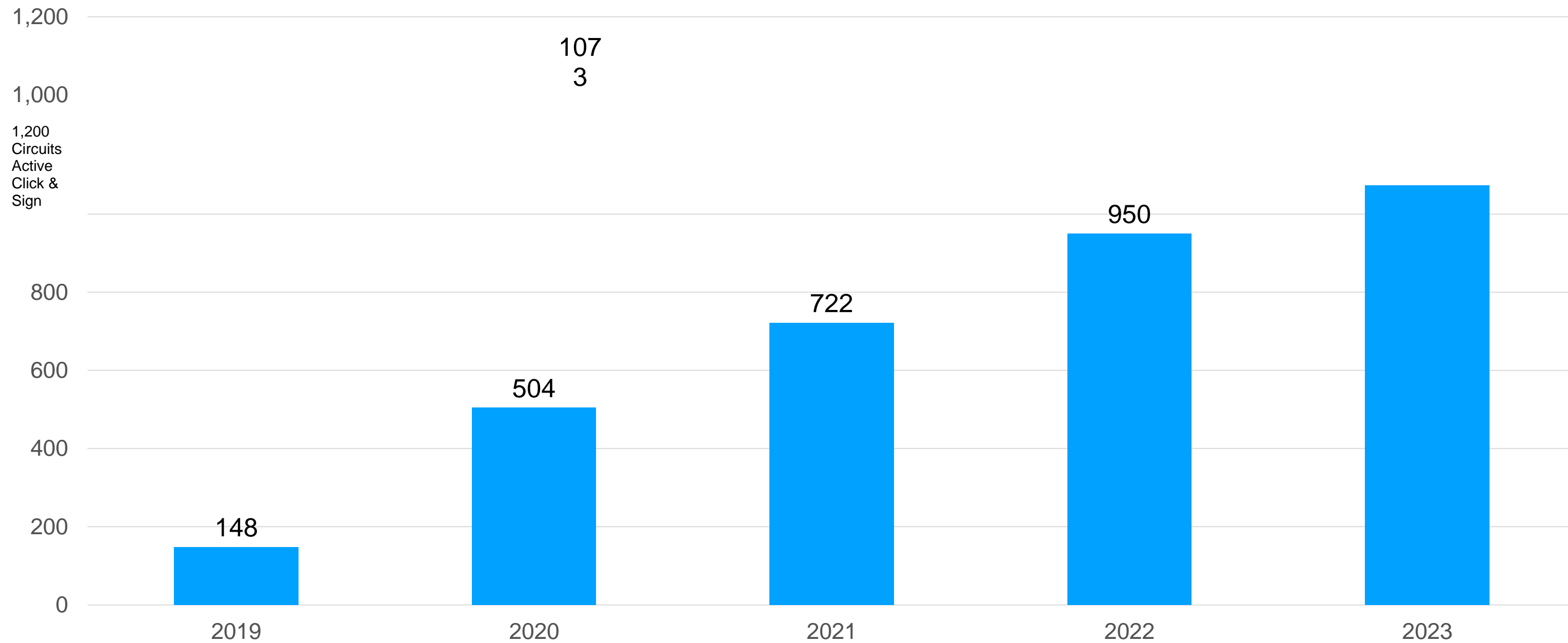

# ACTIVE CLICK & SIGN STANDARD CIRCUITS - SEPTEMBER



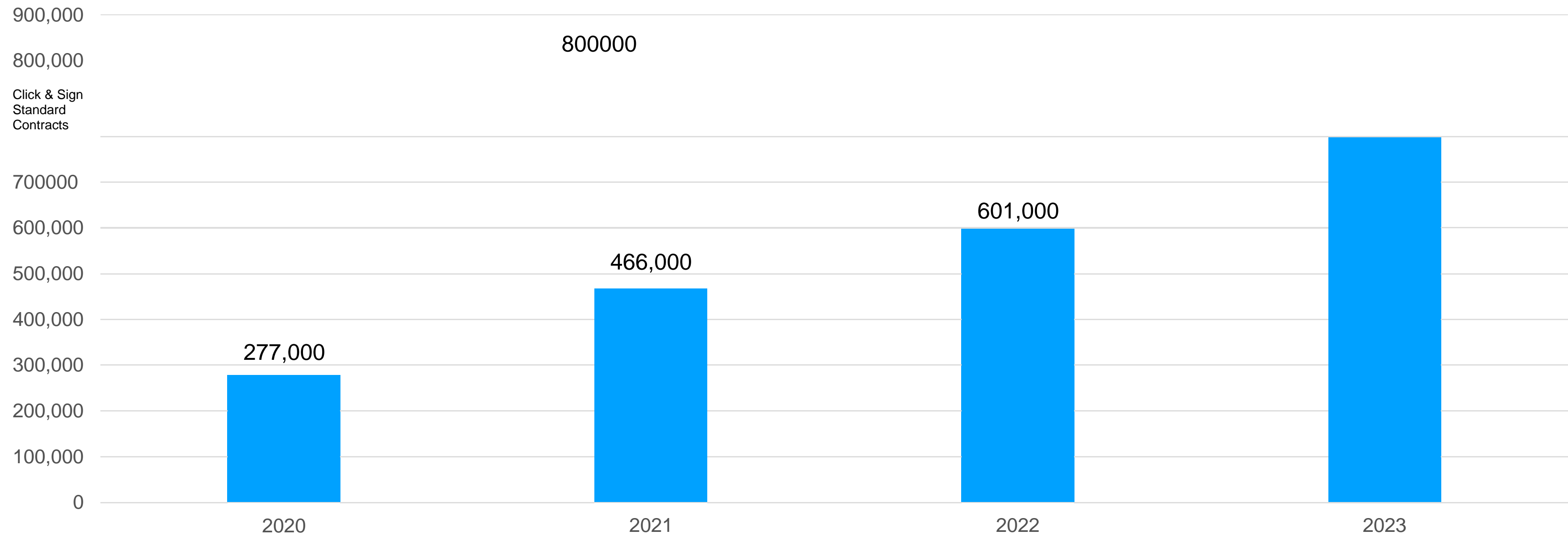

Contracts generated through Click & Sign Standard circuits continue to rise, with a 33.30% increase in 3Q financing in Latin America.

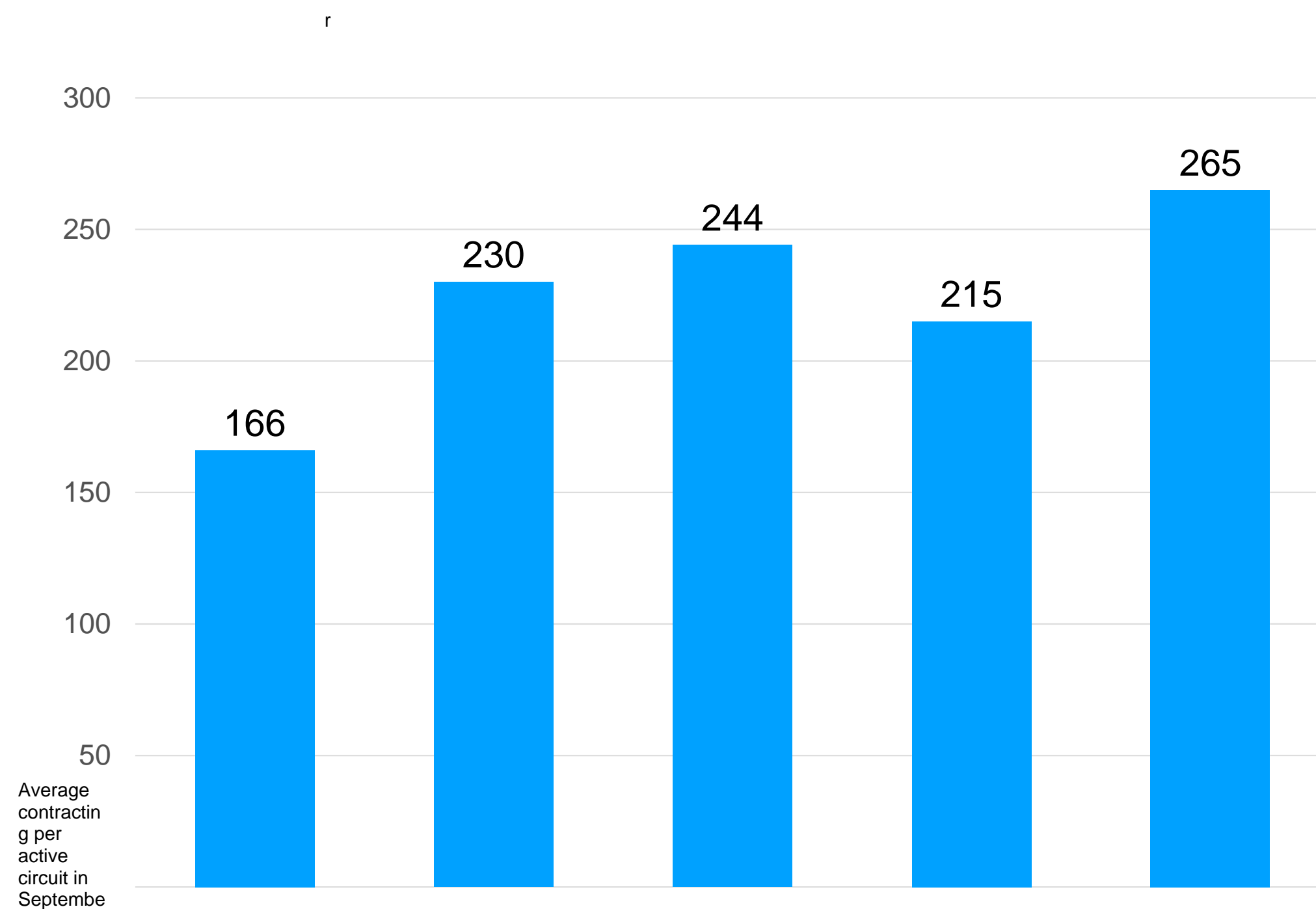

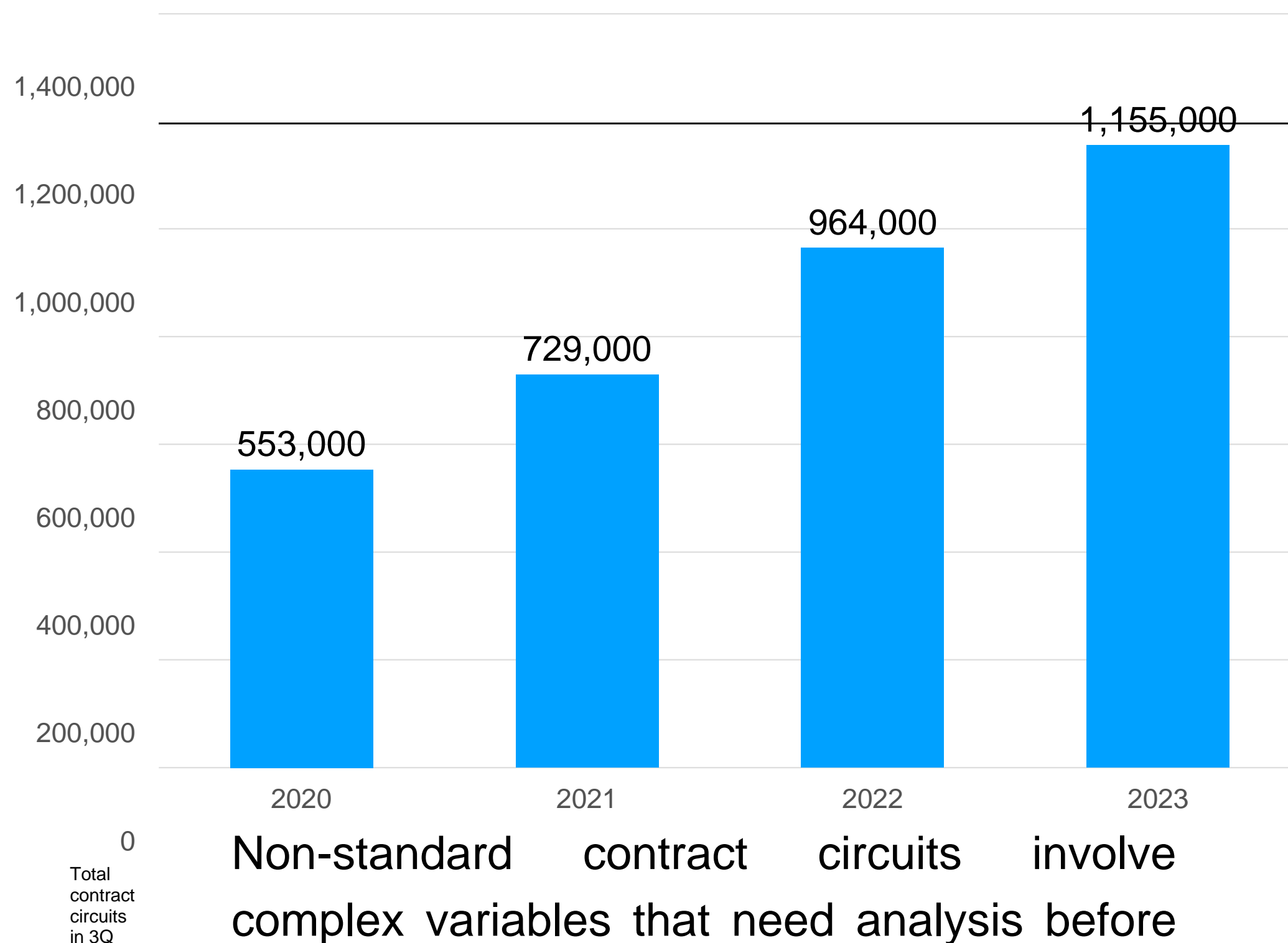

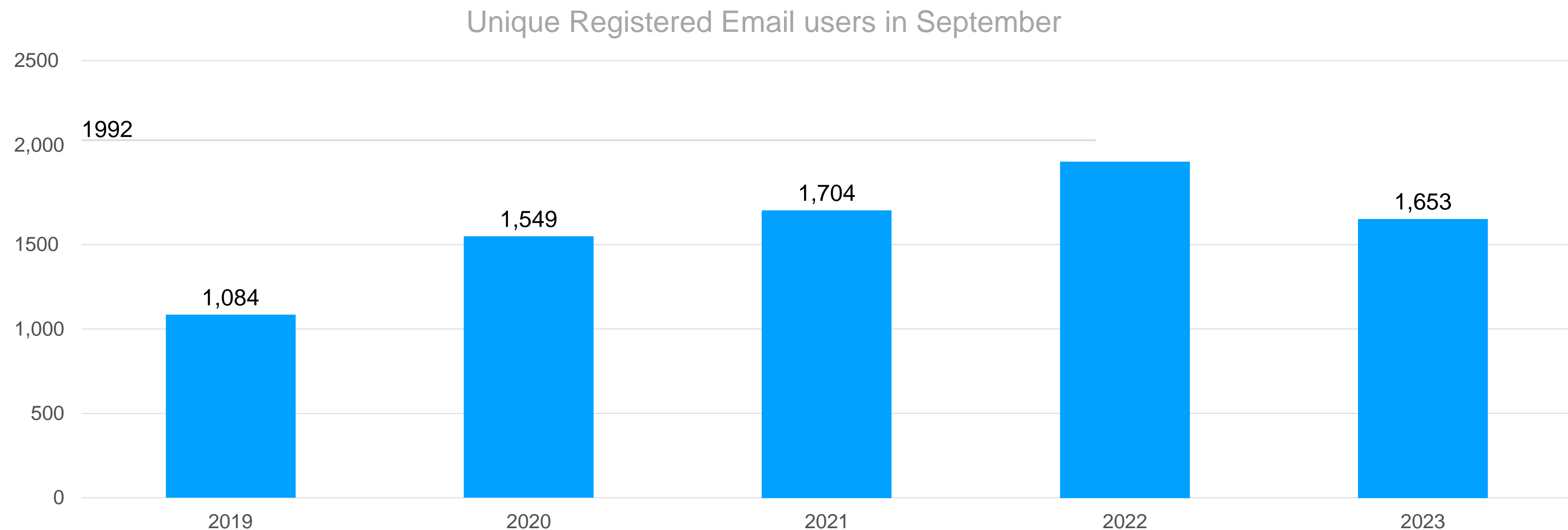
# QUARTERLY PRODUCTION OF OTHER CONTRACT CIRCUITS

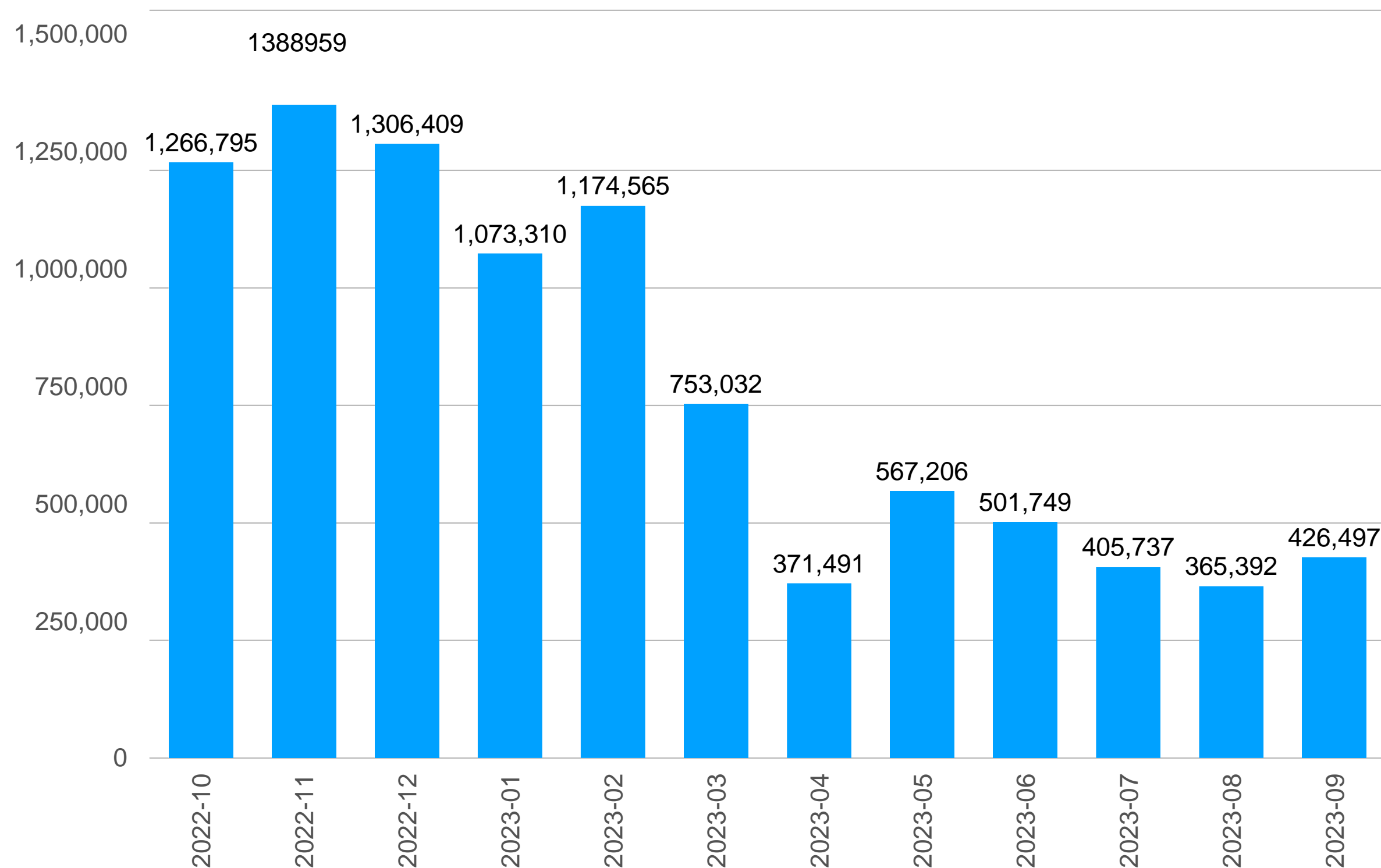
# UNIQUE USERS OF REGISTERED EMAIL



The unique Registered Email users for September are 18% lower compared to September 2022 due to the service cutoff by 4-72. However, it is almost back to 2021 levels and is on the rise.

Monthly Production of Registered Email



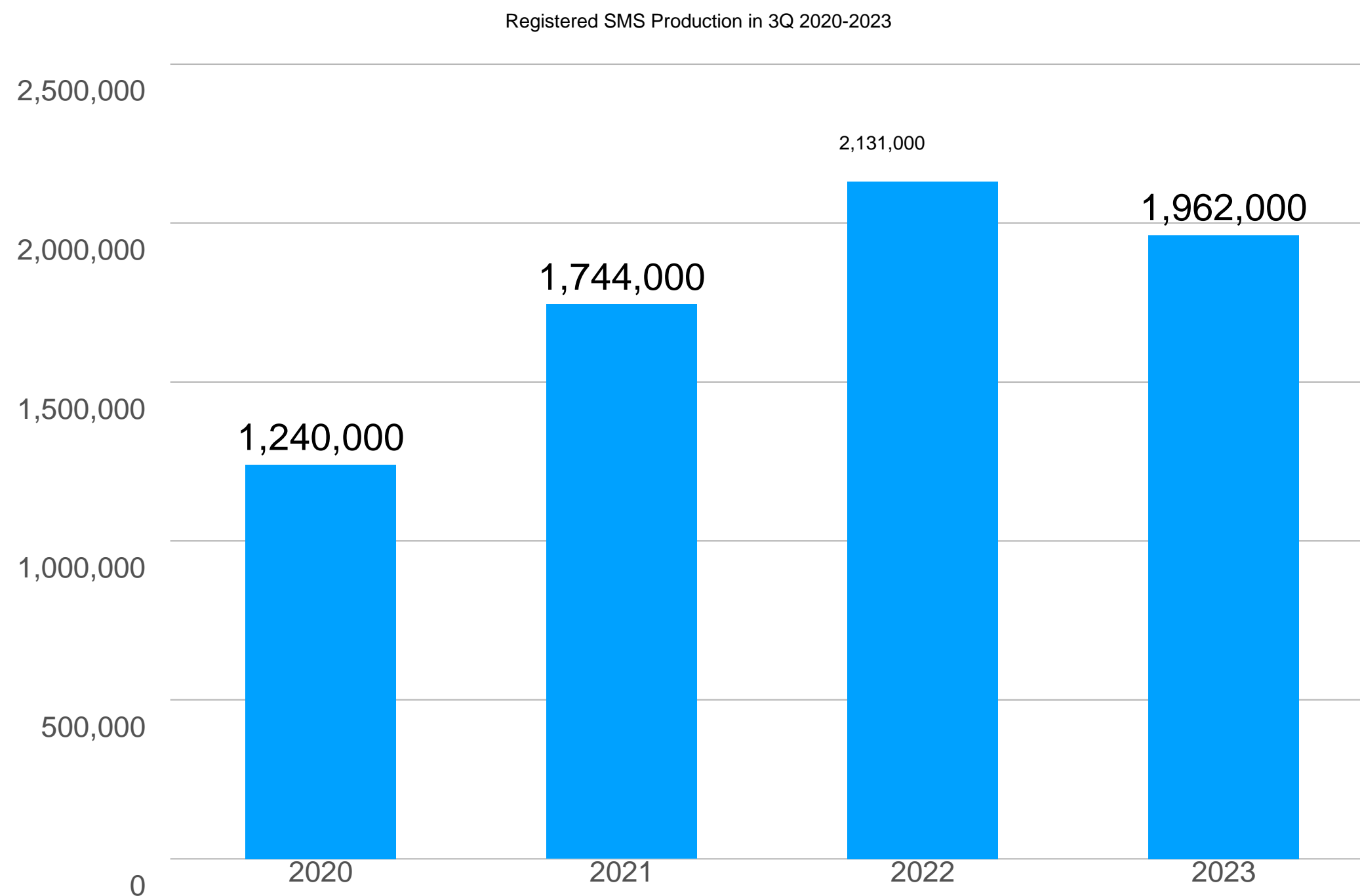
Registered email has been disrupted due to non-payment by Colombian emails, and its usage has diversified in terms of users as the usage by Colombian public entities has significantly decreased. The main traffic now comes from notifications of infrastructure services, insurance, and utility claims.

# QUARTERLY PRODUCTION OF REGISTERED SMS

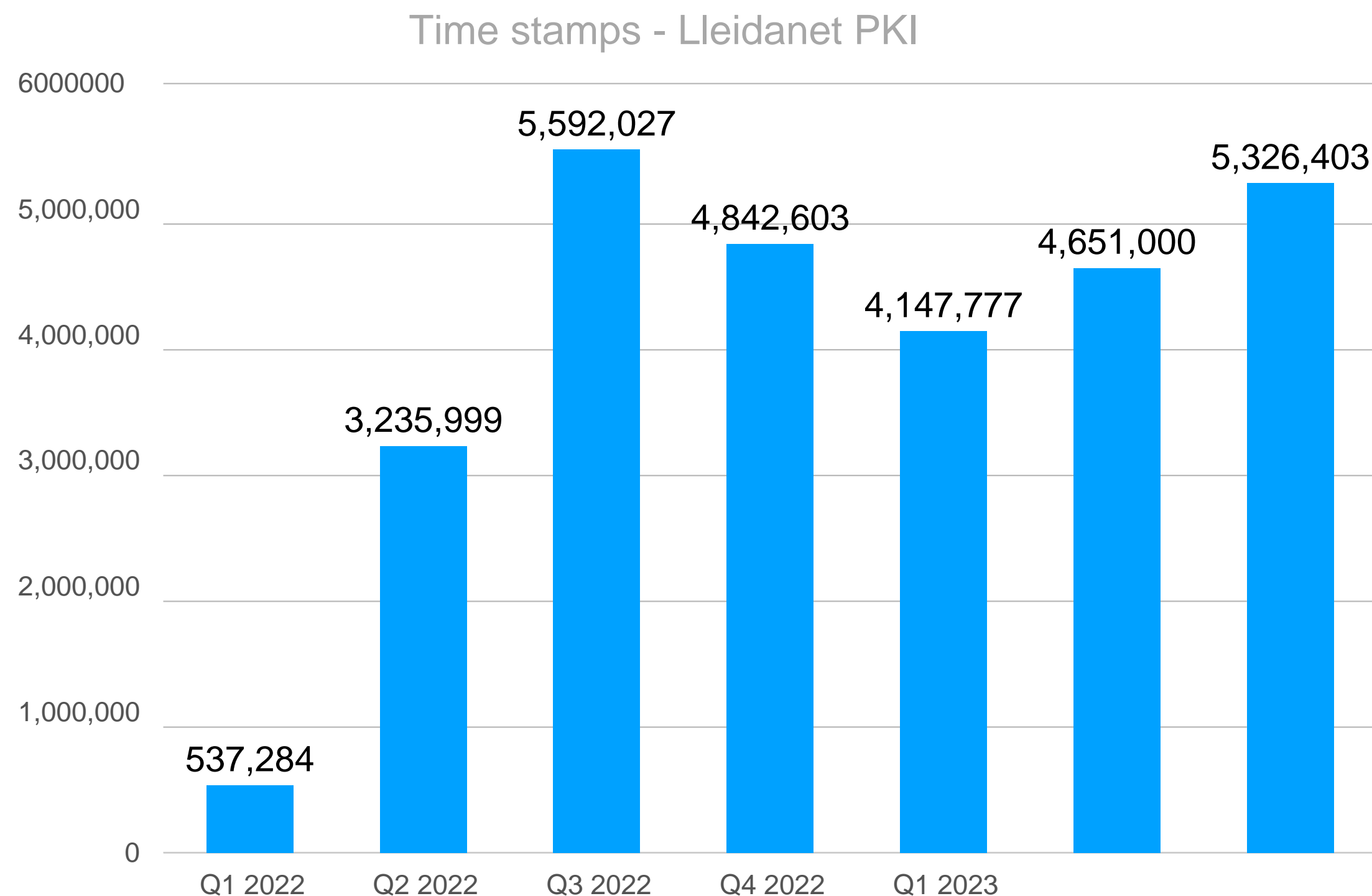


SMS registered traffic in 3Q 2023 shows a slight decrease compared to 2Q 2022. The primary source of traffic is insurance company claims and utility notifications in Europe, credit card debt, and notifications from administrations.

# LLEIDANET PKI - TIME STAMPS PRODUCTION



Time stamps are used to finalise documents or ensure the date and time of a specific document. There has been a slight 4.8% decrease in usage compared to the 3Q 2022.

This service is currently being used for EIDAS signatures across Europe, the Dominican Republic, Peru, and Colombia.
